## 6.3 Quality improvement strategies adopted by the institution for each of the following:

### **6.3.1 Curriculum Development**

Though the curriculum is designed by the Pt.Ravishankar Shukla University, Raipur, C.G, but for effective curricular delivery we give more importance to academic improvement. At the same time we also give equal importance to overall development of the students by encouraging them to participate in various forums, such as student councils, NCC & managing committees.

The college relies upon the traditionally trusted teaching strategy i.e. the Chalk and Talk method. At the same time the college has taken many initiatives to introduce the modern technological resources such as internet, Projectors and OHP's etc for the effective delivery of the lessons. In addition to this the college invites experts from various fields to share their knowledge with the students. Furthermore, the college too organizes study tours, remedial classes for slow learners, assignments of projects etc.

### **6.3.2 Teaching and Learning**

The institution has framed for itself various strategies which enhance the quality improvement. These strategies are framed by the college keeping in view the quality changes required for the development of the college. This criterion was judged against the procedure adopted for admissions to various courses provided by the college; it is based on student's academic records. The rules and regulations set by the affiliating University and the State Government are strictly followed for students' admission. Apart from the lecture method of teaching, group discussion, field studies, debates, tutorials, seminars, study tours etc are adopted for proper understanding of the subjects. The college has well experienced faculty members. The faculty members of various departments participate actively in academic programmes. The college is having rich and organized library. The library staff is well qualified and their services and experience is used in updating library for the optimum use by the students. Students are evaluated time to time by the

subject teachers, the results are discussed in the class and drawbacks of students are corrected. The teachers are given full permission to enrich their knowledge through Seminars, Refresher Courses, and Orientation Courses etc. The college follows the self-appraisal method to evaluate the performance of faculty, which is used for correcting shortfalls. The college encourages the teachers to participate in self-enriching courses whenever different institutions organize them. Teaching material is also collected through internet from renowned Universities.

### **6.3.3 Examination and Evaluation**

Instructions of the university have to be followed by the exam department of the college. As St. Vincent Pallotti College is affiliated to Pt. Ravi Shankar Shukla University, we follow the examination system of the university. University fixes 25% marks in aggregate and 75% attendance.

- Monthly tests are conducted and results are displayed on the notice board.
- Remedial classes are conducted for slow learners.

### **6.3.4 Research and Development**

Faculty members of the college are encouraged to participate in various research projects. The Management encourages the members of the faculty to take up membership of professional research bodies and participate in research activities to further enhance their research capabilities. Sufficient motivation is given to the students to actively participate in seminars, workshops, panel discussions for quality enhancement.

### **6.3.5 Library, ICT and physical infrastructure / instrumentation**

The college library caters to the needs of faculty and students by providing them various study materials relevant to their subjects. INFLIBNET facility is also available with the library which exposes faculty and students of the college to various resources.

The college provides computer and internet facilities at two different location in the campus i.e. in computer science department and in library. All staff members and students can

use it for their subject based and assignment based solutions. The institution is constantly working for upgradation of IT infrastructure by using new technology in terms of hardware (for example LCD ,Projectors) as well as software (Such as latest versions of Operating System) .Also the college intends to upgrade the PCs with latest configurations.

The college has always created a niche for itself in the field of sports. The college has since long times, been participating in various inter university, university level tournaments , In sports, our college provides indoor and outdoor games to student. We proudly tell that our students are regularly getting selected for various national and international levels of sports.

### **6.3.6 Human Resource Management**

In the institution, the process of assessing adequate human power requirements, staff recruiting, monitoring and planning professional development programmes for personnel development and seeking appropriate feedback responses is very good.
